Floyd, thanks for touching base. Scoping directives will be posted, announced and news-released. I don't have a timeline, though. It is possible that SEPA (Ecology and county) and NEPA (Corps) directives may come out at different times. The idea here is that if one is ready sooner, the consultants should be set to task without delay. With the expected overlap, this approach would keep the process moving forward.

Dear Dr. Ahern:

Thank you for the recent discussions about Health Impact Assessments (HIA). The State Environmental Policy Act (SEPA) co-lead agencies, Whatcom County and the Department of Ecology, appreciate your interest to conduct a HIA for the proposed coal export terminal projects in Washington and Oregon in a way that complements the environmental review process for the Gateway Pacific Terminal/Custer Spur projects.

The co-lead agencies understand that you would like to develop a memorandum of understanding that would enable your team to engage in dialog with the relevant regulatory agencies and contractors involved in the Gateway Pacific Terminal/Custer Spur projects review process. After careful consideration, the SEPA co-lead agencies respectfully decline to enter into a memorandum of understanding.

As SEPA co-leads, our agencies are legally responsible for conducting the environmental review under SEPA. We looked to our adopted Communication Protocol Agreement which identifies communication limitations and documentation procedures that must be followed to preserve the independence, objectivity, and integrity of the County and State evaluation and decision making processes. Given the complexities of the Gateway Pacific Terminal/Custer Spur projects, it is important that the co-lead agencies protect and maintain the integrity of the SEPA process. More specifically, we are declining to enter into a memorandum of understanding because we feel that information pertaining to the development of the Environmental Impact Statement (EIS) under SEPA must be managed strictly through mutual agreement between the co-leads until it is ready for public distribution. This approach allows the co-leads the greatest ability to consistently manage data and other information and produce a thorough and rigorous EIS.

As we have conveyed in earlier conversations, if the proposed HIA is provided to the co-leads during review of the draft EIS and prior to issuing the final EIS, we will consider its findings.

Finally, we are aware of other qualified entities that also will be conducting analyses that may inform our evaluation of impacts during the DEIS process. Our agencies are obligated to have a common and consistent protocol to how we consider and reference such analyses. Establishing a formal relationship with any one of these entities raises questions as to why we would not have similar relationships with others.

In closing, the co-leads respect the academic expertise of your organization, and we appreciate the effort invested in developing your purpose and objectives as well as your efforts to coordinate with the EIS process.

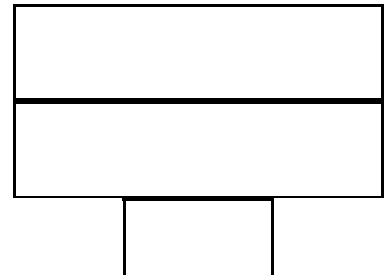
