~~The following goals are adopted to guide the development and adoption of comprehensive plans and development regulations of those counties and cities that are required or choose to plan under RCW 36.70A.040. The following goals are not listed in order of priority and shall be used exclusively for the purpose of guiding the development of comprehensive plans and development regulations:~~

- ~~1. **Urban Growth.** Encourage development in urban areas where adequate public facilities and services exist or can be provided in an efficient manner.~~
- ~~2. **Reduce Sprawl.** Reduce the inappropriate conversion of undeveloped land into sprawling, low-density development.~~
- ~~3. **Transportation.** Encourage efficient multimodal transportation systems that are based on regional priorities and coordinated with county and city comprehensive plans.~~
- ~~4. **Housing.** Encourage the availability of affordable housing to all economic segments of the population of this state, promote a variety of residential densities and housing types, and encourage preservation of existing housing stock.~~
- ~~5. **Economic Development.** Encourage economic development throughout the state that is consistent with adopted comprehensive plans, promote economic opportunity for all citizens of this state, especially for unemployed and for disadvantaged persons, promote the retention and expansion of existing businesses and recruitment of new businesses, recognize regional differences impacting economic development opportunities and encourage growth in areas experiencing insufficient economic growth, all within the capacities of the state's natural resources, public services, and public facilities.~~
- ~~6. **Property Rights.** Private property shall not be taken for public use without just compensation having been made. The property rights of landowners shall be protected from arbitrary and discriminatory actions.~~
- ~~7. **Permits.** Applications for both state and local government permits should be processed in a timely and fair manner to ensure predictability.~~

- 1 ~~8. **Natural Resource Industries.** Maintain and enhance natural resource-based~~
2 ~~industries, including productive timber, agricultural, and fisheries industries.~~
3 ~~Encourage the conservation of productive forest lands and productive~~
4 ~~agricultural lands, and discourage incompatible uses.~~
- 5 ~~9. **Open Space and Recreation.** Encourage the retention of Retain open space,~~
6 ~~and development of enhance recreational opportunities, conserve fish and~~
7 ~~wildlife habitat, increase access to natural resource lands and water, and~~
8 ~~develop parks and recreation facilities.~~
- 9 ~~10. **Environment.** Protect the environment and enhance the state's high quality of~~
10 ~~life, including air and water quality, and the availability of water.~~
- 11 ~~11. **Citizen Participation and Coordination.** Encourage the involvement of~~
12 ~~citizens in the planning process and ensure coordination between communities~~
13 ~~and jurisdictions to reconcile conflicts.~~
- 14 ~~12. **Public Facilities and Services.** Ensure that those public facilities and services~~
15 ~~necessary to support development shall be adequate to serve the development~~
16 ~~at the time the development is available for occupancy and use without~~
17 ~~decreasing current service levels below locally established minimum standards.~~
- 18 ~~13. **Historic Preservation.** Identify and encourage the preservation of lands, sites,~~
19 ~~and structures, that have historical or archaeological significance.~~
- 20 ~~14. **Shoreline Management.** Per RCW 36.70A.480 Shorelines of the State, the~~
21 ~~goals and policies of the Shoreline Management Act, as set forth in RCW~~
22 ~~90.58.020, are added as one of the goals of the Growth Management Act.~~

1 **B. Urban Versus Rural Distinctions**

- 2 1. Whatcom County shall primarily become a government of rural areas in land
3 use matters directed towards agriculture, forestry and other natural
4 resources and natural resource based industries. The county shall work with
5 citizens to define a variety of types of rural areas based on the characteristics
6 and needs of different areas. This Section shall not preclude county
7 governance of large urban industrial areas outside of the city UGA's (see
8 Cherry Point below), developed urban areas within urban growth areas not
9 yet annexed, and developed rural areas where the "urban" designation is
10 inappropriate.
- 11 2. The county shall discourage urban level development outside Urban Growth
12 Areas and outside of areas currently characterized by a development
13 threshold greater than a rural development density.
- 14 3. Whatcom County shall promote appropriate land uses and allow for infill
15 within rural settlements characterized by existing commercial, industrial and
16 intensive residential development greater than a rural development density.
17 These areas should be clearly delineated, and not expanded beyond logical
18 outer boundaries in accordance with RCW 36.70.070(5). Impacts on rural
19 character, critical areas and other economic considerations as well as the
20 availability of capital facilities and rural levels of service must be considered
21 before allowing infill in these areas.
- 22 4. In the next 20 years, Whatcom County should discourage "new fully
23 contained communities" (as defined and authorized by RCW 36.70A.350)
24 outside designated Urban Growth Areas.
- 25 5. Whatcom County should undertake a public process to define rural areas and
26 rural growth as distinct from urban areas and urban growth.

27 **C. Urban Growth Areas**

- 28 1. Urban growth needs shall be met by a combination of in-fill within cities and
29 by growth within designated municipal and non-municipal Urban Growth
30 Areas.
- 31 2. The size and location of Urban Growth Areas shall be consistent with adopted
32 local policies and with the capital facilities plans.
- 33 3a. The most current, accurate population projections based on a range provided
34 for Whatcom County by the Office of Financial Management shall be used as
35 the basis for determining that Urban Growth Areas shall include sufficient
36 area to permit the urban growth that is projected to occur in the county for
37 the succeeding twenty-year period.

- 1 3b. The County and Cities shall develop a consistent approach to calculating the
2 land supply needed within an urban growth area. This approach shall
3 consider limitations imposed by critical area regulations, infrastructure
4 needs, open space, existing uses, local market factors and the ability of the
5 jurisdiction to provide services. It is recognized that the above limitations
6 may vary by jurisdiction, but the method for applying them shall be
7 consistent. Urban growth areas shall permit a range of densities and uses;
8 however, in recognition of community character, these uses and densities
9 may vary among jurisdictions.
- 10 4. Urban Growth Areas shall be evaluated at least every ten years to determine
11 if they contain sufficient area to accommodate the urban growth that is
12 projected for the succeeding twenty-year period. The market factor for each
13 Urban Growth Area shall also be evaluated to determine whether the land
14 supply is adequate to meet the needs of the community or whether the land
15 supply is excessive and contributing to sprawl.
- 16 5. Urban Growth areas should be established in a way that preserves
17 agricultural land, forestry, mineral resources, water resources, and critical
18 areas. Urban growth shall maintain proper buffers from natural resource
19 areas to minimize conflicts with natural resources and industries based on
20 them.

21 **D. City Urban Growth Areas**

- 22 1. The Urban Growth Areas for the small cities shall be of an adequate size to
23 allow them to become viable economic centers with a balance of jobs and
24 housing. The small cities shall do appropriate planning to ensure adequate
25 distribution of land uses and services at a range of urban densities and
26 zoning classifications.
- 27 2. Urban Growth Areas for cities shall include those areas contiguous to cities
28 and with urban characteristics as defined by the Act. The Geneva area in
29 Bellingham's UGA is characterized by urban development, but is also
30 identified by the city and county as a Water Resource Protection UGA
31 because of its location in the Lake Whatcom Watershed. Lake Whatcom is the
32 drinking water source for much of the Bellingham urban area. Geneva is
33 appropriate to include in an urban growth area, but is not an area where
34 additional urban development is desirable.
- 35 3. Cities shall develop a plan to provide urban level water and sewer services
36 within their Urban Growth Areas. This plan should be developed in
37 cooperation with existing water purveyors and other municipal corporations
38 providing water or sewer services within each city's Urban Area, and should
39 be implemented through interlocal agreements. Short term and long term
40 boundaries may be used to facilitate provision of urban levels of service and
41 to not preclude future urban densities as defined within the Whatcom County
42 Comprehensive Plan.

- 1 4. Existing cities should absorb additional population at a range of densities
2 appropriately responsive to the city's community vision before extending city
3 Urban Growth Areas into areas where growth would adversely impact critical
4 areas and resource lands. In those small cities entirely surrounded by flood
5 plains, critical area and resource lands or within Shellfish Protection Districts,
6 the county and the city shall seek to negotiate a balance between protection
7 of resources and the allocation of adequate land area to meet the growth
8 needs of the city and to maintain the desired character of the community.
- 9 5. All cities should grow in an efficient manner while maintaining their character
10 and, where reasonable, shall provide for adequate open space between cities
11 to prevent strip development.
- 12 6. Cities should be encouraged to provide positive incentives for in-fill.

13 **E. Non-City Urban Growth Areas**

- 14 1. Urban Growth Areas may also be established in areas that are not contiguous
15 to existing cities, and are already characterized by urban growth where
16 adequate facilities and services can be provided and which are intended to
17 meet needs not met by cities and their Urban Growth Areas.
- 18 2. Non-city urban growth areas, for already urbanized unincorporated
19 residential areas shall be encouraged to infill in a way that will facilitate
20 efficient provision of facilities and services consistent with the scale of
21 development.
- 22 3. Cherry Point shall be designated as an unincorporated industrial urban
23 growth area in recognition of existing large scale industrial land uses.
24 Additional large scale development shall be encouraged consistent with the
25 ability to provide needed services and consistent with protecting critical areas
26 along with other environmental protection considerations. The Cherry Point
27 industrial area is an important and appropriate area for industry due to its
28 access to deep water shipping, rail, all-weather roads, its location near the
29 Canadian border, and its contribution to the County's goal of providing family
30 wage jobs.
- 31 4. The County shall assure that there are plans to provide appropriate levels of
32 urban facilities and services within non-city Urban Growth Areas. These plans
33 should be developed by special purpose districts, water associations and
34 private service providers within each of these Areas, and should be
35 implemented, where appropriate, through interlocal agreements. Short term
36 and long term boundaries may be used to facilitate provision of urban levels
37 of service.

1 **F. Contiguous, Orderly Development and Planning in Urban Growth Areas**

- 2 1. Cities, the county and special districts shall execute interlocal agreements to
3 coordinate plans for and manage growth in Urban Growth Areas prior to
4 annexations. Interlocal agreements shall acknowledge and implement the
5 Countywide Planning Policies.
- 6 2. Interlocal agreements shall incorporate clear and reasonable criteria for
7 orderly annexation. The county and the cities shall establish a process to
8 incorporate representative citizen input into interlocal agreement and
9 encourage appropriate districts to participate. If adequate procedures are
10 developed to replace it, the Boundary Review Board may be replaced.
- 11 3. All urbanized areas currently within urban growth boundaries associated with
12 cities should be encouraged to annex to cities. Orderly annexations with
13 logical boundaries shall be encouraged. Interlocal agreements shall specify
14 guidelines on size, timing of annexations and urban levels of development,
15 and tax revenue sharing when appropriate.
- 16 4. Within Urban Growth Areas, cities shall not extend water and sewer utilities
17 without an adopted program for annexation and an adopted Capital Facilities
18 Plan. Exceptions may be made in cases where human health is threatened as
19 determined by the County Health Department. If water extensions are made,
20 they shall be consistent with the service area boundaries and other
21 provisions within the adopted Coordinated Water System Plan.
- 22 5. In the areas where utilities presently extend beyond city limits, but are within
23 Urban Growth Areas, the city, county, and the existing water purveyors for
24 the area should jointly plan with the county. The County shall adopt zoning
25 which reflects this joint planning.
- 26 6. Unless specifically provided for by state statues, Cities, other municipal
27 corporations, and other public and private utilities shall not extend urban
28 levels of water service to serve urban uses outside Urban Growth Areas. If
29 legally allowed water extensions are made outside of Urban Growth Areas,
30 the maximum number of connections shall not exceed the density allowed
31 under the associated zoning. The number of connections shall be specified in
32 a legally binding document at the time the extension is approved. Property
33 contiguous to extension of utilities necessary to solve existing water
34 deficiencies, but which cannot benefit from them because of zoning
35 constraints, shall not be assessed for those improvements.
- 36 7. The availability of pipeline capacity required to meet local needs and/or
37 supply shall not be used to justify development counter to the countywide
38 land development pattern and shall not be considered in conversions of
39 agricultural land, forestry, and rural areas.

- 1 8. The cities, other municipal corporations, public utilities, and the county shall
2 cooperate to identify and balance the needs of each jurisdiction and entity
3 when planning for transition of services and annexation within Urban Growth
4 Areas. This intergovernmental cooperation and coordination should be
5 reflected in revenue agreements, work programs for joint projects, and
6 regional solutions adopted by the affected parties.
- 7 9. Major transportation, utility and greenway corridors shall be planned within
8 Urban Growth Areas. Development shall be consistent with these corridors.
9 The county shall ensure conformance through the permit process and
10 incentive programs.
- 11 10. Interlocal agreements shall include provisions for agreed upon development
12 standards within Urban Growth Areas. Unless a different standard is
13 negotiated, the more rigorous of the standards shall be enforced by the
14 county.
- 15 11. The county and the City of Bellingham shall establish, through the Urban
16 Fringe Subarea Plan update, the policies, zoning and criteria to comply with
17 current state Growth Management law.
- 18 12. To encourage contiguous, orderly development and annexation in Urban
19 Growth Areas around cities, the county shall designate Urban Residential
20 zones limiting density to a maximum of one dwelling unit per five acres in
21 undeveloped areas until urban level utilities are provided. Developed or
22 partially developed areas presently zoned Residential-Rural shall retain that
23 zoning. In the Bellingham Urban Growth Area, substantial development and
24 subdivisions already have occurred without annexation. The revised Urban
25 Fringe Subarea Plan and a new Interlocal Agreement between the City of
26 Bellingham and the county will address sequence and timing for annexations,
27 subdivisions, and urban levels of development.
- 28 13. In Urban Growth Areas where development is occurring based on the
29 presence of utilities, urban development shall meet common urban standards
30 including fire flow requirements and supply. The county and the cities will
31 work together to develop reasonable standards over time.
- 32 14. The County and the cities shall coordinate drainage, stormwater
33 management and flood control in Urban Growth Areas and work toward the
34 development of common standards.

35 **G. Affordable Housing**

- 36 1. The county and the cities shall take actions to ensure a balance of housing
37 and economic growth consistent with each jurisdiction's employment base
38 and diverse income levels and to reduce commuting times and traffic
39 congestion.
- 40 2. The county and the cities shall plan for a range of housing types and costs
41 commensurate with their affordable housing needs.

- 1 3. Affordable housing should be convenient to major employment centers and
2 public services or be designed to accommodate public transportation.
- 3 4. The county and the cities shall promote innovative techniques and develop
4 strategies to provide for affordable housing with design, density, lot sizes and
5 development standards that provide for a variety of housing types.
- 6 5. The county and the cities shall review existing regulations and policies that
7 exclude or discourage affordable housing in their communities and shall not
8 adopt regulations and policies which do so. Mobile, modular, and
9 manufactured homes on individual lots, mobile home parks, accessory units,
10 inclusionary zoning, mixed use, and increased densities shall be reviewed as
11 affordable housing alternatives.
- 12 6. The county and the cities should work with the private sector, other public
13 and non-profit agencies, citizen groups, and trade representatives to assure
14 that there is an adequate supply of sites available for affordable housing and
15 to encourage housing design that is compatible with the surrounding
16 neighborhoods.
- 17 7. Low income housing shall not be concentrated in only a few communities or
18 neighborhoods.
- 19 8. The county and the cities shall consider reducing impact and/or mitigation
20 fees for affordable housing provided in a proposed development.
- 21 9. Each jurisdiction should explore options for providing shelter for the
22 homeless.

23 **H. Open Space/Greenbelt Corridors**

- 24 1. Adequate open space is vital to the quality of life and sense of place in
25 Whatcom County. The county, cities, Port of Bellingham, and other
26 appropriate jurisdictions should coordinate protection of linked greenbelts,
27 within and between Urban Growth Areas, parks, and open space to protect
28 wildlife corridors and to enhance recreational opportunities, public access and
29 trail development.
- 30 2. The county and the cities shall plan for greenbelts and open space in their
31 Comprehensive Planning processes and coordinate with each other. Open
32 space systems should include lands which contain natural areas, habitat
33 lands, natural drainage features, and/or other environmental, cultural and
34 scenic resources. With increased residential densities, jurisdictions also
35 should ensure provision of adequate neighborhood parks and play areas
36 within safe bicycling and walking distance for children.
- 37 3. The county and the cities shall encourage, to the extent it is feasible,
38 separation of Urban Growth Areas through planning, zoning, development

1 regulations, open space purchase, conservation easements and other
2 mechanisms which may be appropriate. Also, an array of incentives such as
3 density bonuses, design flexibility and transferable development rights shall
4 be offered to affected land owners.

5 4. The County and Cities should work cooperatively to protect and restore
6 stream corridors within Urban Growth Areas that support anadromous fish.

7 **I. Economic Development and Employment**

8 1. Whatcom County recognizes that a healthy economy, which provides
9 opportunity for diverse segments of the community, is important to the
10 quality of life in the area. The Greater Whatcom Comprehensive Economic
11 Development Strategy (CEDS) “is intended to put forth economic
12 development alternatives for Whatcom County that will support jobs creation,
13 with an emphasis on higher wage jobs and diversification”

14 2. New business development and expansion of existing businesses are key
15 factors in providing “family wage” jobs and a strong tax base. Economic
16 development that pays family wage rates should be encouraged. Industrial
17 land designations must be sufficient to permit the concentration of industry
18 in appropriate locations beyond 20 years. In order to attract new industry
19 and provide for expansion of existing industries, the county and the cities will
20 designate land supply of sufficient size and diversity to provide a range of
21 suitable locations for industrial development. The designation of this land
22 shall be established in a way that preserves natural resource based industries
23 and critical areas.

24 3. To provide sufficient land supply for industrial growth and development,
25 industrial designations must not only include lands suitable for development,
26 but also lands suitably zoned to provide adequate buffers. It is also important
27 that these lands and buffers be conserved with appropriate land use and
28 zoning provisions to ensure that they will be available for future use.

29 4. Encourage business location, retention, and expansion according to city and
30 county comprehensive plans in order to meet current and future demand for
31 diverse business and industry. Work with funding agencies and the private
32 sector to facilitate extension of adequate sewer, water, telecommunications
33 and road access to existing commercial and industrial-zoned properties,
34 creating shovel-ready sites. Cities and county may utilize the “Quick Sites”
35 economic development program through OTED, which links strategic
36 elements of planning, zoning, environmental review, and permitting with the
37 business-siting effort.

38 5. The county and the cities should include an economic development element
39 in their Comprehensive Plans. Economic development elements should be
40 consistent with the CEDS. Economic development shall be coordinated with
41 environmental concerns to protect the quality of life. Planning efforts should

- 1 address economic sustainability. As part of the comprehensive planning
2 process and through implementation of the comprehensive plan, the County
3 shall develop and adopt goals, policies and regulations that protect resource
4 land industries and support and encourage resource-based industries.
- 5 6. The county and the cities should continue to cooperate through the
6 Partnership for a Sustainable Economy to maintain the CEDS for
7 infrastructure funding. Other appropriate organizations, businesses, and
8 individuals should be involved in the process.
- 9 7. Economic vitality and job development shall be encouraged in all the cities
10 and in designated areas of the county consistent with community growth
11 policies, particularly addressing adequacy of transportation corridors, public
12 transportation, impacts on the environment, and the ability of the area to
13 provide urban services.
- 14 8. Economic development should be encouraged that:
- 15 a. Does not adversely impact the environment;
- 16 b. Is consistent with community values stated in local comprehensive
17 plans;
- 18 c. Encourages development that provides jobs to county residents;
- 19 d. Addresses unemployment problems in the county and seeks innovative
20 techniques to attract different industries for a more diversified
21 economic base;
- 22 e. Promotes reinvestment in the local economy;
- 23 f. Supports retention and expansion of existing businesses.
- 24 9. The County and the cities recognize the need for the protection and
25 utilization of natural resources and resource lands including agricultural,
26 mineral, forestry and fishing. As part of a broad based economy, productive
27 timber, agriculture and fisheries industries should be supported in a
28 sustainable manner.
- 29 10. The cities and county agree to set policies for approving proposals to
30 authorize siting of Major Industrial Developments for large or resource-based
31 industries outside of Urban Growth Areas (as per RCW 36.70A.365). The
32 master planning process for specific manufacturing, industrial, or commercial
33 businesses shall address infrastructure, buffers, environmental protection,
34 sprawl, resource lands, critical areas, and land supply.
- 35 11. Whatcom County encourages siting of industrial uses in proximity to and to
36 further utilization of our access to deep water and port facilities for shipping,
37 rail, airports, roadways, utility corridors and the international border.

1 **J. Countywide Transportation Facilities and Strategies**

- 2 1. A Regional Transportation Planning Organization (RTPO) has been
3 established in Whatcom County to conduct regional, cooperative
4 transportation planning. The RTPO has completed a Regional Transportation
5 Plan (RTP) including countywide transportation policies. The RTP has been
6 approved by a regional transportation Policy Board consisting of elected
7 representatives of most area jurisdictions. The Transportation Chapter of the
8 Whatcom County Comprehensive Plan and the Comprehensive Plans for each
9 of the City's must be consistent with the RTP as it is amended. The county
10 and the cities will continue to support the RTPO on an on-going basis to
11 coordinate transportation planning across Whatcom County.
- 12 2. Whatcom County jurisdictions shall encourage alternative modes of
13 transportation to the single occupancy vehicle. Each jurisdiction shall
14 encourage:
- 15 a. Use of public transportation;
- 16 b. Development of liked on-street bicycle routes and pedestrian and
17 bicycle trail corridors;
- 18 c. Adequate pedestrian facilities;
- 19 d. Connections between different modes of transportation;
- 20 e. Intermodal connection of freight transportation.
- 21 3. To encourage use of single occupant vehicle alternatives and development of
22 pedestrian scale neighborhoods, high density residential development shall
23 be encouraged in urban growth areas with particular attention to those
24 locations within cities and in close proximity to arterials and main transit
25 routes.
- 26 4. Cities are particularly encouraged to support transit and pedestrian friendly
27 mixed use developments within their UGAs to help achieve the goals
28 supported in these policies.
- 29 5. Where the roadway level of service (LOS) adopted in local comprehensive
30 plans cannot be maintained as a result of proposed new development, that
31 development shall be denied, unless the proponents agree to pay a
32 proportionate share of the cost of maintaining the LOS.
- 33 6. Strategies for maintaining established levels of service may include
34 transportation demand management techniques, project impact mitigation
35 fees, enhanced access to public transportation service, and/or other steps to
36 reduce or limit traffic congestion.
- 37 7. Priorities shall be established and expenditures coordinated for countywide
38 bicycle and trail corridors. Bicycle and pedestrian-specific trails and other

1 facilities shall be included during project planning and review. Coordinated
2 corridors and cost sharing should be explored among all responsible and
3 interested parties.

4 8. Whatcom County should work cooperatively with the Whatcom County
5 Council of Governments, Cities, Whatcom Transit Authority and other
6 agencies with jurisdiction to plan for inter-county and international
7 transportation links, such as airports, border crossings, passenger rail,
8 freight rail, transit, ferries, and other transportation facilities.

9 **K. Siting of Public Facilities**

10 1. As part of the comprehensive planning process, the county and the cities
11 shall identify appropriate land for public facilities which meets the needs of
12 the community, such as schools, recreation, transportation and utility
13 corridors, human service facilities, and airport and other port facilities. In
14 order to reduce land use conflicts, policies related to a design component
15 shall be incorporated in the comprehensive plans.

16 2. The county and the cities will implement a cooperative and structured
17 process, which includes early and continuous public involvement, to consider
18 siting of essential public facilities of a regional and statewide nature. State
19 facilities shall conform to local siting procedures.

20 3. Public facilities that generate substantial travel demand should be sited along
21 or near major transportation and public transit corridors, where available.

22 4. The county and the cities shall work with their respective school district to
23 encourage siting of schools in conjunction with areas where substantial
24 development exists or is projected and near public transportation corridors.

25 5. Sharing of corridors for major utilities, trails and other transportation
26 rights-of-way is encouraged when not in conflict with goals to protect wildlife,
27 public health and safety.

28 **L. Impact Fees**

29 1. The county and the cities are encouraged to adopt fair and reasonable impact
30 and/or mitigation fee ordinances to ensure that new growth pays its fair
31 share of the cost of capital facilities, such as transportation improvements,
32 parks, and schools.

33 2. The county and cities shall work with their school districts to develop impact
34 fee formulas as appropriate to the district's capital needs.

35 **M. Intergovernmental Cooperation**

36 1. To adequately plan for growth and implement the policies of the Growth
37 Management Act, the governmental jurisdictions in Whatcom County,

1 including the Lummi Nation and Nooksack Tribe, and the Port of Bellingham
2 shall work together to establish on-going mechanisms to improve
3 communication, information sharing and coordinated approaches to common
4 problems.

5 2. Whatcom County governments should communicate with neighboring
6 counties and governments in British Columbia and work cooperatively on
7 growth management issues that cross county and national borders.

8 **N. Water Quality and Quantity**

9 1. The cities, and the county, in cooperation with other municipal corporations,
10 tribal governments, federal and state agencies, and public and private
11 utilities shall cooperate in the protection of water resources and in drawing
12 upon said water to support growth.

13 2. The Cities and the County in cooperation with other municipal corporations
14 and tribal governments shall adopt zoning regulations and development
15 standards to protect water resources. Where there are potential conflicts with
16 designations required by the Growth Management Act, such as natural
17 resource lands and critical areas, water resource protection shall generally
18 have priority.

19 3. Jurisdictions shall cooperate to protect and restore water resources and fish
20 habitat within UGA's and across jurisdictional boundaries to maintain quality
21 of life and economic health in Whatcom County.

22 4. Jurisdictions involved in the development of ground and/or surface water
23 management plans shall pursue the adoption and implementation of the
24 plans, as well as coordination and integration of the plans into local
25 comprehensive plans as appropriate. Examples of such plans include the
26 Lake Whatcom Management Plan, WRIA 1 Watershed Management Plan,
27 Shellfish Protection District Plans and drinking water source protection plans.

28 5. All jurisdictions should participate in the process to establish a countywide
29 water resource management body in accordance with the Watershed
30 Management Act and other applicable federal, state and local regulations to
31 inform GMA planning efforts.

32 6. All jurisdictions shall maximize reduction of water pollutants from stormwater
33 runoff and combined sewer overflows.

34 **O. Fiscal Impact**

35 1. It is recognized that if the Growth Management Act and these policies are
36 implemented to their maximum extent, county government may eventually
37 lose the tax base needed to operate essential services, including the criminal
38 justice function and the Offices of Treasurer, Assessor, and Auditor, which

1 serve all jurisdictions in the area. Revenue-sharing shall be addressed in
2 inter-local agreements between Cities and the County.

3 **P. Private Property Rights**

- 4 1. As required in the Growth Management Act, private property shall not be
5 taken for public use without just compensation having been made. It is not
6 the purpose of this paragraph to expand or reduce the scope of private
7 property already provided in local, state and federal law.
- 8 2. The county as required by Whatcom County Home Rule Charter Section 1.11,
9 and cities should establish a pro-active process to anticipate potential takings
10 and other private property issues and resolve them out of court.
