Update on Recycling

New Slater Road Lautenbach Recycle Park has been in process for over a month. Email from Bill Angel to Jennifer Hayden with update.

The solid waste handling facility permit application for the Slater Road Lautenbach Recycle Park—Material Recovery facility has been submitted by the operator.

Additional documentation is needed to consider it a complete application, subject to public notice and Ecology review.

The operator will provide additional documentation within two weeks to complete the permit application, including a more complete plan of operation, a revised safety plan, and a revised traffic flow pattern.

The operator is installing a weigh scale at this time.

The activities at the site are low risk for storm water and groundwater contamination.

The main pollution prevention concerns for this solid waste management activity are leachate containment and wind-blown littering.

Leachate from the PTAG material placement area is directed to sanitary sewer.

Litter is controlled with high-walled tipping areas for mixed paper and PTAG, timely placement of paper inside the building prior to baling, and timely transfer of PTAG to transport trailers.

Litter cleanup by hand is also an important way the operator controls litter.

Worker safety is another primary concern.

Worker hazard awareness, visibility, and communications, as well as consistent vehicle movements and signaling were observed during recent health inspections of the facility.

Moving SSC to the Waste Hauler Position on SWAC

Option to move Rodd Pemble with SSC to Waste Collection Industry to open up Business/Industry.

2021 Whatcom County Comprehensive Solid and Hazardous Waste Management Plan Update
