



Tree Removal Permit Intake Checklist

- Completed and signed Tree Removal Permit Application emailed as a PDF to epermits@co.whatcom.wa.us
- Application Fee: See current [Unified Fee Schedule](#). Per UFS 2843 all permits and applications are subject to a 3% Technology fee. The 3% fee is calculated on the permit/application fees due. Make checks payable to Whatcom County Planning and Development Services. You may also pay by debit or credit card, at the Planning & Development Services Permit Center Counter.
- Completed and signed Agent Authorization form (if applicable).
- Completed ISA Basic Tree Risk Assessment.
- Tree survey or aerial estimation.
 - ◆ Option 1 - Tree Survey:
 - Measure average canopy radius (r) for each tree to be removed.
 - Calculate existing canopy area using the formula: Canopy Area (CA) = πr^2 .
 - Total the sum of tree canopy area to be removed.
 - ◆ Option 2 – Aerial Estimation (Can be done with Google Earth, Bing Maps, or other similar mapping program using aerial imagery):
 - Obtain aerial imagery of site.
 - Measure site boundaries (right click on aerial photos and look for option to “measure distance”).
 - Measure canopies of individual trees or stand area using leading edges at the forest boundary.
- Site plan, drawn to a scale, which depicts at a minimum all of the following:
 - ◆ Location of any trees that are to be removed (indicate species).
 - ◆ Existing and proposed tree canopy areas.
 - ◆ All trees to be removed must be flagged and indicated on site plan.
 - ◆ All buildings, existing and proposed.
 - ◆ Parking, access roads and driveways.
 - ◆ Critical areas (e.g.: wetlands, streams) located.
 - ◆ Ditches.
 - ◆ Property lines, corner pins.
 - ◆ Topography (contours, slope grade).
 - ◆ Utilities.
 - ◆ Erosion and Sedimentation Control Measures.
- Applicable photographs of affected tree(s).
- If mitigation is required: drawn to scale planting plan showing location, species, and 20-year canopy area of the new trees.

- WCC 20.51.430 (1)a – Lake Whatcom Watershed Overlay District & WCC 20.71.354 (1)a - Water Resource Protection Overlay District: Removal of any hazard trees considered an emergency within the definition of “hazard tree” in Chapter 20.97 WCC. **Within 30 days after the emergency** is abated the landowner shall submit photo documentation with a form provided by Whatcom County.
- WCC 16.16.235.B.4 – Activities Allowed with Notification – Critical Areas - The felling of hazard trees within critical areas and buffers, with an approved tree risk assessment completed by a qualified professional.

Definitions

Fair market value of a development means the open market bid price for conducting the work, using the equipment and facilities, and purchase of the goods, services and materials necessary to accomplish the development. This would normally equate to the cost of hiring a contractor to undertake the development from start to finish, including the cost of labor, materials, equipment and facility usage, transportation and contractor overhead and profit. The fair market value of the development shall include the fair market value of any donated, contributed or found labor, equipment or materials.

WCC 16.16.900 Definitions (Critical areas)

- "Hazard tree" (outside the shoreline jurisdiction) means a tree whose risk evaluation, as determined through a Whatcom County approved tree risk assessment method, is high. Risk evaluation is the combined measurement of: tree failure identification, probability of failure, potential damage to permanent physical improvements to property causing personal injury, and consequences. A tree that constitutes an airport hazard is considered a hazard tree. A hazard tree whose failure is imminent and consequences of damage to permanent physical improvements to property causing personal injury are significant is considered an emergency. "Imminent" in this instance means failure has started or is most likely to occur in the near future, even if there is no significant wind or increased load. Imminent may be determined by a qualified consultant (defined in this section) or when mutually agreed upon by a landowner and Whatcom County.
- "Hazard tree" (within the shoreline jurisdiction) means any tree that is susceptible to immediate fall due to its condition (damaged, diseased, or dead) or other factors, and which because of its location is at risk of damaging permanent physical improvements to property or causing personal injury.
- "Qualified professional" or "qualified consultant" means a person with experience and training with expertise appropriate for the relevant critical area subject in accordance with WAC [365-195-905\(4\)](#). A qualified professional must have obtained a B.S. or B.A. or equivalent degree in biology, soil science, engineering, environmental studies, fisheries, geology, geomorphology or a related field, and related work experience, and meet the following criteria: 6. A qualified professional for tree risk assessment means a certified arborist or certified tree professional with a current ISA Tree Risk Assessment Qualification.

WCC 20.97.436.4 (Zoning)

- Tree, significant: Any evergreen tree, 12 inches or greater in diameter at breast height (DBH) or deciduous tree, eight inches or greater DBH. Diameter at breast height shall be measured four and one-half feet above existing grade.

WCC 20.97.171.2 (Zoning)

- Hazard tree: Tree whose risk evaluation, as determined through a Whatcom County approved tree risk assessment method, is high. Risk evaluation is the combined measurement of: tree failure identification, probability of failure, potential damage to permanent physical improvements to property causing personal injury, and consequences.
