

Instructions to Waive Interest After LFOs Are Paid In Full

During the COVID Stay Home Order, if you don't have the case number or numbers, you need to contact the LFO Clerk at 360-778-5619. You need one motion for each case number. Once the Stay Home Order is lifted, you can look up your case(s) on the Court's public computer in the Computer Room at the Clerk's Office on the 3rd floor of the Courthouse.

***IMPORTANT** – Fill out the attached forms, one form for each case number. Any reduction or change to LFOs will apply only to the case listed on your Motion. If you have 3 cases, fill out three sets of forms. This Motion provides the Court with the reasons for your request. Give as much detail as you feel necessary for the Judge to understand your current situation. Attach any supporting documentation.

Either mail the original forms or drop them off at the Whatcom County Superior Court Clerk's Office to the attention of the LFO Clerk. Currently hearings are not being held due to COVID and the LFO Clerk will assist you with getting your motion before the Court and provide you with a copy once the Order is signed.

Once the Order is signed, check with the LFO Clerk what your next steps are toward vacating your conviction.
